The exhibitor hereby applies to the producer of the 2017 Annual Lowrider Hopping Nationals to have the vehicle described in this entry blank displayed therein and agrees that, if the application is accepted, he will display and perform in competition under the following terms and conditions:

In consideration of being allowed to participate in any way in the Cool Cars, CCE Hydraulics, Inc. and Show Cars, Inc. production of the 2017 Low Rider Hopping Nationals, you, the exhibitor and signatory of this entry application, agree to the following terms, conditions and waivers:

1. You understand and agree that Cool Cars, CCE Hydraulics, Inc. and Show Cars, Inc. shall have the sole authority to make any and all Final decisions regarding your entry and its participation in the competition
2. You agree not to bring any alcohol or drugs to the event and that you will abide by all fire and police safety rules and codes, including but not limited to driving and performing with extreme caution within the Event and on the Event's grounds. You must arrive with as little gas as possible in the vehicle to be in competition. At all times when you are not competing you agree to use your battery disconnects to disarm all of the vehicle's batteries. Once at your exhibit location, you agree to tape the gas cap closed, use of battery disconnects is mandatory when not in competition.
3. In consideration of this entry, the owner and his/her family and crew agree to permit the producer or its assigns the use of their names and pictures of the entered vehicle for publicity, advertising and commercial purposes (including newspapers, magazines, radio and television) before, during and after the event, and do hereby relinquish any rights whatsoever to any photos taken in connection with the event, and give permission to publish or sell or otherwise dispose of said photographs to producer or its assigns. All publicity and advertising rights are reserved by the producer or
4. Neither the producer, the sponsor, nor any officer, director or shareholder, thereof, or the owner of the building at which the show is produced, shall be responsible or liable for any loss or damage to all or part of the exhibitor's vehicle, trailer, display, material and/or parts. And the exhibitor hereby waives any and all rights he or she may have against them for such loss or damage.
5. No commercial advertising is allowed with entries unless they are appearing in conjunction with paid commercial space. A single sign may be used, but large ad signs, handbills, or business card distribution is prohibited.
6. You agree to carry appropriate property, liability and other insurance to cover your vehicle, display and/or all other material used at or in connection with the Event and to protect yourself and any person (including any minor) assisting you or under your direction and/or control from any and all property loss, liability or physical or other injury or damage arising out of or in connection with the Event.

You agree to hereby release, waive, discharge, covenant not to sue and forever discharge Cool Cars, Inc., CCE Hydraulics, Brian Gillespie, Show Cars, Inc., Carl Casper, the KEC and the Kentucky Fair Board, O'Reilly Automotive Stores, Inc., O'Reilly Automotive, Inc. and their respective past, present, and future parents, subsidiaries, and related entities and, as applicable, their owners, managers, affiliates, agents, subcontractors, employees, & all sponsors from any and all liabilities claims, actions, damages, costs, or expenses of any nature arising out of or in any way connected with your participation in or attendance at the Event, and you further agree to indemnify and hold each of such parties harmless against any and all such liabilities, claims, actions, damages, costs or expenses including, but not limited to, all attorneys' fees and disbursements up through and including any legal action or appeal. You, the exhibitor and signatory of this entry application understand that this waiver of claims and release of liability includes any claims based on the negligence, action or inaction of any of the above noted parties, and covers bodily injury (including death), property damage, and loss by theft or otherwise whether or not occurring before, during or after the Event.

You agree to grant Cool Cars, Inc., CCE Hydraulics, Inc. and Show Cars, Inc. the right to utilize you the Exhibitor, your image, your vehicle, display, crew's image, and or likeness in connection with any commercial photos, posters, programs, brochures, advertisements & promotion in all media including but not limited to magazines, TV, newspaper, radio, internet, video, or film of the Event without any compensation to you.
9. No entry fees will be refunded.
10. You have read this entry application thoroughly and have had the opportunity to seek legal advice on anything you did not understand. You agree that the terms of this signed entry application supersede any and all prior and/or contemporaneous agreements and understandings whether written or oral between You and Cool Cars, Inc., CCE Hydraulics, Inc., Brian Gillespie, Show Cars, Inc., Carl Casper or You and any other parties released in paragraph 6 above. Nothing herein shall be modified unless agreed to in writing by You and Cool Cars, Inc., CCE Hydraulics, Inc., Brian Gillespie, Show Cars, Inc., Carl Casper. Both parties agree that all disputes they are unable to settle shall be decided by arbitration in the Commonwealth of Kentucky and pursuant to the commercial arbitration rules of the American Arbitration Association.
