CAR CLUBS WILL BE LIMITED TO 6 VEHICLES. IMPORTANT — READ RULES, TERMS, CONDITIONS AND WAIVERS:

In consideration of being allowed to participate in any way in the Show Cars, Inc. production of the 2017 Carl Casper Custom Show (the "Event"), You, the exhibitor and signatory of this entry application, agree to the following terms, conditions and waivers:

1. You agree to arrive as early as possible on setup day. All entries will be subject to final approval and space availability at their time of arrival. If the Event is filled to capacity prior to your arrival, or your entry is found to be unacceptable, you will be fully refunded any monies you pre-paid for the Event.
2. You understand and agree that Show Cars, Inc. in its sole discretion, will make all decisions in regard to where your exhibit will be located at the Event. And once your exhibit is set up within the Event, you agree not to remove it prior to the official end of the show without the written permission of Show Cars, Inc.
3. You agree not to bring any alcohol or drugs to the event and that you will abide by all fire and police safety rules and codes, including but not limited to driving with extreme caution and at very slow speeds within the Event and on the Event's grounds. Your display must be made of fireproof materials, and you must arrive with as little gas as possible in the vehicle to be displayed. Once placed at your exhibit location, you agree to tape the gas cap closed, disconnect and tape the battery cables until the official conclusion of the Event.
4. You agree to provide your own crowd barriers, exhibit display materials and electric cords and connections. You agree to use only extension cords that are heavy duty with a third ground wire. You agree to place lights with care and safety. The KFEC will charge for electricity, the cost \$50 if ordered now! \$175 if you wait until move in. Pay at Move-in.
5. You agree to carry appropriate property, liability and other insurance to cover your vehicle, display, and/or all other material used at or in connection with the Event and to protect yourself and any person (including any minor) assisting you or under your direction and/or control from any and all property loss, liability or physical or other injury or damage arising out of or in connection with the Event.
6. You agree to hereby release, waive, discharge, covenant not to sue and forever discharge Show Cars, Inc. Carl Casper, Inc. Carl Casper, the KEC and the Kentucky Fair Board; the Commonwealth of Kentucky, O'Reilly Automotive Stores, Inc., O'Reilly Automotive, Inc. and their respective past, present and future parents, subsidiaries and related entities, and

as applicable, their owners, managers, affiliates, agents, subcontractors, and employees, and all other Event participants, sponsoring agencies, sponsors, advertisers, and owners and lessees of the premises used to conduct the Event from any and all liabilities, claims, actions, damages, costs, or expenses of any nature arising out of or in any way out of or in any way connected with your participation in or attendance at the Event, and you further agree to indemnify and hold each of such parties harmless against any and all such liabilities, claims, actions, damages, costs, or expenses including, but not limited to, all attorneys' fees and disbursements up through and including any legal action or appeal. You, the exhibitor and signatory of this entry application understand that this waiver of claims and release of liability includes any claims based on the negligence, action or inaction of any of the above noted parties and covers bodily injury (including death), property damage, and loss by theft or otherwise whether or not occurring before, during or after the Event.

7. You agree to grant Show Cars, Inc. the right to utilize you the Exhibitor, your display, exhibit, cars and staff's image and or likeness in connection with any commercial photos, broadcast, internet, video or film of the Event without any compensation to you.
8. No promotion and/or advertising is allowed with entries unless they are appearing in conjunction with a paid commercial space. A sign may be used to identify major modifications, who did them, and what equipment was used, but large ad signs, handbills, or business card distribution is strictly prohibited.
9. You have read this entry application thoroughly and have had the opportunity to seek legal advice on anything you did not understand. You agree that the terms of this signed entry application supersede any and all prior and/or contemporaneous agreements and understandings whether written or oral between You and Show Cars, Inc. or You and any other parties released in paragraph 6 above. Nothing herein shall be modified unless agreed to in writing by You and Show Cars, Inc. Both parties agree that all disputes they are unable to settle shall be decided by arbitration in the Commonwealth of Kentucky and pursuant to the commercial arbitration rules of the American Arbitration Association. Signing of this entry application constitutes unconditional acceptance of all of the above rules, terms, conditions and waivers.
